PURPOSE OF REQUEST

The Borough of Roselle Planning Board is requesting legal proposals from qualified individuals and firms to provide (“contractor(s)” or “proposer(s)”) to provide Legal Services (Planning Board Attorney) of a specialized nature to the Borough of Roselle Planning Board. Proposals will be evaluated in accordance with the criteria set forth in this RFQ. One or more individuals/firms may be selected to provide services.

PERIOD OF CONTRACT

January 1, 2016 through December 31, 2016

CONTRACT FORM

The successful proposer shall be required to execute the Borough of Roselle Planning Board’s form contract, which includes the indemnification, insurance, termination and licensing provisions. A complete copy of a draft Borough of Roselle Planning Board form contract is available upon request.

It is also agreed and understood that the acceptance of the final payment by Contractor shall be considered a release in full of all claims against the Borough of Roselle Planning Board arising out of, or by reason of, the work done and materials furnished under any Contract awarded.

DETAILED REQUIREMENTS OF THE REQUEST FOR QUALIFICATIONS FOR PLANNING BOARD ATTORNEY

BOROUGH OF ROSELLE FACTS AND FIGURES – The Borough of Roselle is a municipal governmental entity. The Borough was incorporated in 1894. The Borough is governed by the Borough Council which is made up of six members, and the Mayor. The mayor and council representative-at-large are elected by the entire borough. The remaining five council members are elected from five wards, one from each ward in which the member resides. The Borough’s

population is approximately 21,415 and it consists of approximately 2.2 square miles of area. The Borough employs approximately 230 people in about 16 departments and agencies. It owns various buildings, and parks and recreation facilities throughout the Borough. The Borough government provides significant and diverse services to its residents and community members and neighbors..

2. NATURE/ SCOPE OF SERVICES – The Borough of Roselle Planning Board is requesting proposals for Legal Services (Planning Board Attorney).

The Borough of Roselle, has by Ordinance, created the position of Planning Board Attorney, which shall be appointed annually, to represent the Board in all matters. The Board shall fix compensation (salary) for reporting at all meetings and regular matters.

The Borough of Roselle is requesting proposals for Legal Services as Planning Board Attorney. Counsel will, provide representation of the Board at meetings and in litigation, including but not limited to, preparation of pleadings, motions, and discovery documents; participating in all discovery including attendance at all depositions; participation in and attendance at settlement conferences, pre-trial motions and trials, and attendance at all matters relating to Planning. As to matters that may be charged to developer escrows by ordinance, on which are billed beyond salary as set by the Board, the attorney shall be paid an hourly fee as established by Borough policy.

Counsel may also be called upon to provide other types of legal services of a specialized nature.

3. STANDARD REQUIREMENTS OF TECHNICAL PROPOSAL - Proposers should submit a technical proposal which contains the following:

- A. The name of the proposer, the principal place of business and, if different, the place where
- B. Proposer must have a minimum of ten (10) years of experience in representing Planning or Zoning Boards, or representing matters for applicants reporting before such Boards, and a minimum of five (5) years servicing the Borough of Roselle or other governmental entities.
- C. The education, qualifications, experience, and training of all persons who would be assigned to provide services along with their names and titles.
- D. Please provide a description of any particular area(s) of expertise you or your firm may possess that have not been included in the response provided above.
- E. A statement that neither the firm nor any individuals assigned to this engagement are disbarred, suspended, or otherwise prohibited from professional practice by any federal, state, or local agency.
- F. An Affirmative Action Statement (copy of form attached).

- G. A completed Non-Collusion Affidavit (copy of form attached).
- H. A statement that the proposer will comply with the General Terms and Conditions requ
- I. A copy of the proposer's Business Registration Certificate.

4. **SPECIALIZED REQUIREMENTS OF TECHNICAL PROPOSAL -**

A. Proposer must demonstrate extensive experience in Planning, Zoning and Land use matters.

5. **COST PROPOSAL** – The Borough of Roselle has established the following fee schedule, and shall pay a monthly fee of 1,083.00 for meeting attendance and administrative work and project review and consultation through escrow.

By submission of a proposal, proposer acknowledges and agrees to adhere to the fee schedule set forth above.

6. **PROPOSAL EVALUATION** – The Borough Planning Board will select the most advantageous proposals based on all of the evaluation factors set forth at the end of this RFQ. The Borough Planning Board will make the award(s) that is in the best interest of the Borough Planning Board.

Each proposal must satisfy the objectives and requirements detailed in this RFQ. The successful proposer shall be determined by an evaluation of the total content of the proposal submitted. The Borough Planning Board reserves the right to:

- a. Not select any of the proposals.
- a. Select only portions of a particular proposer's proposal for further consideration (However, proposers may specify portions of the proposal that they consider "bundled".)
- b. Award a contract for the requested services at any time within the calendar year after review of the Qualifications and approval of same by the Borough Planning Board. Every proposal should be valid through this time period.

The Borough Planning Board shall not be obligated to explain the results of the evaluation process to any proposer.

7. **PROPOSAL LIMITATIONS** - This RFQ is not intended to be an offer, order or contract and should not be regarded as such, nor shall any obligation or liability be imposed on the Borough Planning Board by issuance of this RFQ. The Borough Planning Board reserves the right at the Borough Planning Board's sole discretion to refuse any proposal submitted.

8. **USE OF INFORMATION** - Any specifications, drawings, sketches, models, samples, data,

computer programs, documentation, technical or business information and the like (“Information”) furnished or disclosed by the Borough Planning Board to the proposer in connection with this RFQ shall remain the property of the Borough Planning Board. When in tangible form, all copies of such information shall be returned to the Borough Planning Board upon request. Unless such information was previously known to the proposer, free of any obligation to keep it confidential, or has been or is subsequently made public by the Borough Planning Board or a third party, it shall be held in confidence by the proposer, shall be used only for the purposes of this RFQ, and may not be used for other purposes except upon such terms and conditions as may be mutually agreed upon in writing.

9. GENERAL TERMS AND CONDITIONS –

- A.** The Borough Planning Board reserves the right to reject any or all proposals, if necessary, or to waive any informalities in the proposals, and, unless otherwise specified by the proposer, to accept any item, items or services in the proposals should it be deemed in the best interest of the Borough Planning Board to do so.
- B.** In case of failure by the successful proposer, the Borough of Roselle Planning Board may procure the articles or services from other sources, deduct the cost of the replacement from money due to the proposer under the contract and hold the proposer responsible for any excess cost occasioned thereby.
- C.** The proposer shall maintain sufficient insurance to protect against all claims under Workmen's Compensation, General, Professional and Automobile Liability.
- D.** Each proposal must be signed by the person authorized to do so.
- E.** The contract shall be in effect through December 31, 2016 unless otherwise stated.
- F.** Proposals may be hand delivered or mailed consistent with the provisions of the legal notice to proposers. In the case of mailed proposals, the Borough Planning Board assumes no responsibility for proposals received after the designated date and time and will return late proposals unopened. Proposals will not be accepted by facsimile or e-mail.
- G.** In accordance with Affirmative Action Law, P.L. 1975, c.127 (N.J.A.C. 17:27) with implementation of July 10, 1978, successful proposers must agree to submit individual employer certifications and numbers or complete Affirmative Action employee information report (form AA-302). Also, during the performance of this contract, the contractor agrees as follows: (a) The contractor or subcontractor where applicable, will not discriminate against any employee because of age, race, creed, color, national origin, ancestry, marital status or affectional or sexual orientation. The contractor will take affirmative action to ensure that such applicants are recruited and employed and that employees are treated during employment, without regard to their age, race, creed, color, national origin, ancestry, marital status, sex or handicap. Such action shall include, but not be limited to the following: employment, upgrading, demotion or transfer, recruitment or recruitment advertising; layoff or termination; rates of pay or

other forms of compensation; and section for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notice to be provided by the Public Agency Compliance Officer setting forth provisions of this non-discrimination clause: (b) the contractor or subcontractor, where applicable, will in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to age, race, creed, color, national origin, ancestry, marital status, sex or handicap; (c) the contractor or subcontractor, where applicable, will send to each labor union or representative or workers with which it has a collective bargaining agreement or other contract or understanding, a notice, to be provided by the agency contracting officer advising the labor union or worker's representative of the contractor's commitments under this act and shall post copies of the notice; (d) the contractor or subcontractor, where applicable, agrees to comply with any regulations promulgated by the treasurer pursuant to the P.L. 1975, c.127, as amended and supplemented from time to time.

- H.** By submission of the proposal, the proposer certifies that the service to be furnished will not infringe upon any valid patent, trademark or copyright and the successful proposer shall, at its expense, defend any and all actions or suits charging such infringement, and will save the Borough Planning Board harmless in any case of any such infringement.
- I.** No proposer shall influence, or attempt to influence, or cause to be influenced, any borough official or employee to use his/her official capacity in any manner which might tend to impair the objectivity or independence of judgment of said official or employee.
- J.** No proposer shall cause or influence, or attempt to cause or influence, any Borough Planning Board officer or employee to use his/her official capacity to secure unwarranted privileges or advantages for the proposer or any other person.
- K.** Should any difference arise between the contracting parties as to the meaning or intent of these instructions or specifications, the Borough Law Department's decision shall be final and conclusive.
- L.** Neither the Borough nor the Borough Planning Board shall not be responsible for any expenditure of monies or other expenses incurred by the proposer in making its proposal.
- M.** The checklist, affidavits, notices and the like presented at the end of this Request for Qualifications are a part of this Request for Qualifications and shall be completed and submitted as part of this proposal.

The contractor or subcontractor, where applicable, will send to each labor union or representative or workers with which it has a collective bargaining agreement or other contract or understanding, a notice, to be provided by the agency contracting officer, advising the labor union or workers' representative of the contractor's commitments under this act and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

The contractor or subcontractor, where applicable, agrees to comply with any regulations promulgated by the Treasurer pursuant to N.J.S.A. 10:5-31 et seq., as amended and supplemented from time to time and the Americans with Disabilities Act.

The contractor or subcontractor agrees to make good faith efforts to employ minority and women workers consistent with the applicable county employment goals established in accordance with N.J.A.C. 17:27-5.2 or a binding determination of the applicable Borough employment goals determined by the Division, pursuant to N.J.A.C. 17:27-5.2.
