

MARRIAGE/CIVIL UNION LICENSE **REQUIREMENTS**

- 1- Proof of residence; any bill, lease or bank statement with there name and address.
- 2- Proof of identity by presenting a driver's license, passport or state/federal I.D.
- 3- The bride, groom & one witness 18 with proper I.D. must come.
- 4- Original birth certificates are required for both. **Must be in English.**
- 5- Social Security cards are required for both. Your S.S. # is required by law and will be confidential.
- 6- If the bride or groom is divorced or widowed, copies of divorce papers or death certificate must be presented. **Must be in English.**
- 7- After application is completed, there is a 72-hour waiting period before the marriage license can be issued. Anyone can pick-up the license after the waiting period.
- 8- **The marriage license fee is \$ 28.00.** To be paid same day, cash only & it has to be the exact amount of money. No personal checks/no money order. **Monies not refundable.**
- 9 - After receiving your marriage license it's good only for 30 days. If you don't get married during that period of time you would have to **re-apply & pay another \$ 28.00 fee.**
- 10-Applying hours for marriage license are from **Monday thru Friday from 9:00 a.m. thru 2:30 pm.**

REQUISITOS PARA CASARSE EN EL ESTADO DE NUEVA JERSEY

- 1) La novia o el novio debe ser residente del pueblo de Roselle.
Necesita prueba de direccion (recivo de la luz/gas/telephone/cuenta de banco/o el contrato de donde renta.)
- 2) **Necesita identificacion con foto:** Licencia de manejar, pasaporte vigente or cualquier identification federal valida en New Jersey.
- 3) Cuando venga a aplicar necesita traer un testigo de 18 anos o mayor y que tenga identification apropiada. **Necesita hablar ingles.**
- 4) Acta de nacimiento **en ingles.**
- 5) Targetas de seguro social. Son necesarias y se mantendra la information en confidencia.
- 6) Si ha estado casado antes necesita traer papeles de divorcio/anulamiento o si es viudo(a) acta de defuncion **en ingles.**
- 7) Despues de aplicar hay un periodo de espera de (72) horas – 3 dias para recojer su licencia de matrimonio.
- 8) El costo es de **\$28.00 dolares** que deberan ser pagado el mismo dia y en efectivo. Debe ser la cantidad exacta y **no hay devolucion de dinero.**
- 9) Despues de recojer la licencia de matrimonio es vigente por 30 dias. Si se vence en ese periodo de tiempo tiene que volver a aplicar y pagar el costo de la applicacion nuevamente.
- 10) Horario para aplicar por la licencia de matrimonio son a seguir:
de Lunes a Viernes de 9:00 a.m. a 2:30 p.m.

Changes recommended following your ceremony

1. Change name on Drivers' license.
2. Change name on car Registration.
3. Change name on car Insurance.
4. Change name on Health Insurance.
5. Change name on Social Security records.
6. Change name on Voter rolls.
7. Change name on Bank accounts.
8. Change name with Credit accounts.
9. Change name on Wills.
10. Change name with Employer.
11. If you are moving, change your address where applicable.
12. If you are a professional person, change name on all professional licenses, etc.
13. Change name on passport.

If you are going to apply for certified copies of your Marriage/Civil Union certificate. The following procedure is required:

1. Contact the Registrar's office in the community where the ceremony was performed.
2. Give the Bride's maiden name, the Groom's name, and the date of marriage/civil union was performed.

ROSELLE VITAL STATISTICS & REGISTRATION

REQUIREMENTS FOR DOMESTIC PARTNERSHIP

1) *Each applicant must supply valid identification that establishes name, age and date of birth. This may be supplied by one or more documents issued by a government agency, such as a certified copy of a birth certificate, driver's license, military identification or state/county identification card.*

2) *Applicants must bring with them proof of common residence, if the residence is outside the State of New Jersey, at least one of the applicants must provide proof of membership in a New Jersey State-administered Retirement System by providing one of the following documents issued by the Division of Pension and Benefits:*

- a) A Personal Benefits Statement from the current or previous year.*
- b) A 1099R from the current or previous year, or*
- c) A Certificate of Pension Membership.*


3) *Applicants must provide proof of joint financial responsibility, evidence by at least one of the following documents:*

- a) Joint deed, mortgage agreement or lease;*
- b) Joint bank account;*
- c) Designation of one of the persons as primary beneficiary in the other person's will;*
- d) Designation of one of the persons as primary beneficiary in the other person's insurance policy or retirement plan; or*
- e) Joint ownership of a motor vehicle.*

4) *Payment in the amount of \$28.00 on the same day only cash/monies not returnable.*

5) *Applying days/hours are Monday thru Friday from 9:00 a.m. to 2:30 p.m.*

Remarriage License Requirements/Reaffirmation of Civil Union



- 1) Bride or Groom must present proof of address – current bill with name and address.
- 2) Proof of identity by presenting drivers license, passport or state/federal I.D.
- 3) Birth certificate. **Must be in English.**
- 4) Social Security cards are required for both. Your SS# is required by law and will be confidential.
- 5) A remarriage license may be issued to any couple in an existing legal marriage with the same spouse. **Must present proof of the date/place of original marriage.**
- 6) There is no waiting period or are blood test required. May pick up marriage license the next working day.
- 7) Bride, groom & one witness 18 with proper I.D. must come same day.
- 8) Remarriage license fee is **\$ 28.00**. To be paid only by cash on day of the application the exact amount. **Monies not refundable.**
- 9) After receiving your marriage license it's only good for 30 days after you pick it up. If you don't use it in that period of time you would have to reapply again.
- 10) Applying days/hours for marriage licenses are **Monday through Friday from 9:00 a.m. to 2:30 p.m.**
